13.2 Planning Application No. **2024/01056/FUL**

Location : Coed Hills, Coed Hill Rural Artspace, Llantrithyd Road, St Hilary

Proposal : This proposal is for the creation of 2 new wildlife ponds. The first pond will be approximately 30 x 22 metres and irregular in shape with the water depth ranging from very shallow edges to a depth of 1.5m in the centre. The second pond will be approximately 30 x 26 metres also of irregular shape and 1.5 maximum depth in the centre. All excavated spoil will be used to create additional wildlife habitat as south facing bunds.
