# LLANFAIR COMMUNITY COUNCIL Minutes of Council Meeting held at St Hilary Village Hall On Thursday, 6<sup>th</sup> March 2025 at 7.00pm.

Item 3: Community Police Matters.

PCSO Davies gave Members a thorough report on recent activity:

St Hilary – Report of out-of-control dogs.

Outcome: Police attended and spoke to all parties – Warning letter issued to dog owner control measures implemented to avoid repeat incidents.

Rural Crime within the Vale has increased significantly with criminals travelling to the area from England in vehicles fitted with false plates. Significant damage is occurring at farms, both to livestock and crops and property, such as gates etc.

Hare coursing activity is using dogs to catch hares and criminals are betting on which dog will catch the hare. This is being live streamed via the internet. Dogs are being trained on common land in the Vale.
