As the Welsh Government Elections are to take place on 7<sup>th</sup> May 2026, it was **proposed** by Councillor Loch, seconded by Councillor Llewellyn and **resolved** that the date of the Annual Meeting and Ordinary meetings in May is changed to the 14<sup>th</sup>.

**Item 10: To discuss Councillors' Allowances for the year 2025/2026.**

Members were reminded to advise the Clerk, in writing by e-mail, if they wish to claim the annual and/or printing allowance for the current financial year.

**Item 11: To report on Highway Issues.**

Issues with a number of potholes and a pulling in space in St Hilary were advised to the Clerk for reporting to the Highways Department at the Vale Council.

**Item 12: To discuss the Vale of Glamorgan Community Councils Boundary Changes.**

Councillor Loch advised that she had recently attended a webinar hosted by One Voice Wales giving some information on the procedure regarding the town and community councils boundary changes and the formation of new councils and the dissolution of current ones.

Much of the webinar was on the legal employment rights of the Clerk with regard to possible transfer to the new Council, retirement or redundancy. The Clerk will be attending the same webinar on the 24<sup>th</sup> February 2026.

**Item 13: To give any update on the appointment of a Minority Authority Representative (MAR) onto the Governing Body of Llanfair Primary School.**

**Item 14: Reports of Representatives.**

14.1 Councillor Loch reported on the recent local committee meeting of One Voice Wales held on that 12<sup>th</sup> January and had circulated a presentation given at the meeting by Older People's Commissioner for Wales.

Councillor Loch then reported on the reconvened Annual General Meeting of One Voice Wales held on 21<sup>st</sup> January 2026. A motion to reduce the quorum requirement for the AGM was passed.

The following motions had been forwarded by a number of town and community councils:

1. *Penarth Town Council - this AGM instructs One Voice Wales/National Executive Committee to engage with Welsh Government to make Community and Town Councils statutory consultees in collaborative arrangements for considering future bus provision in their area – motion passed.*

2. *Newtown and Llanllwchaiarn Town Council - this conference instructs One Voice Wales to investigate the provision of professional legal advice on Welsh law to Councils and report back to the membership – motion passed.*
3. *Gelligaer Community Council - this AGM calls upon One Voice Wales to formally encourage local councils to advocate for the Welsh Government to seek full devolution of the Crown Estate to Wales – motion passed.*
4. *Arfon Dwyfor Area Committee - the AGM calls upon One Voice Wales to investigate how specific assets transfer officer can be funded for the sector – motion passed.*
5. *Chepstow Town Council - calls upon One Voice Wales to lobby the Welsh Government to consider increasing and extending the financial threshold for free school meals in Wales to secondary school children in line with other devolved governments in the United Kingdom – motion passed.*
6. *One Voice Wales National Executive Committee - to confirm an increase in membership fees for 2026/27 by up to 4%.*

14.2 It was noted that Councillor Bonnar had forwarded to Members, notes that she had taken with regard to the Community Liaison Meeting held on 22<sup>nd</sup> January 2026.

14.3 *At this point it was reported that the 'Trim Trail' at Llanfair Primary School requires some immediate maintenance work costing £20,000. The Clerk to make enquiries into if a grant donation from the Community Council can be awarded under Section 137 of the Local Government Act 1972 which enables local councils to spend a limited amount of money for purposes for which they have no other specific statutory expenditure.*
